The parties acknowledge, however, that dismissal of this action with prejudice would not prevent the Plaintiffs from seeking relief if Plaintiffs were somehow denied any of the legal benefits or obligations derived from marriage in the future. The parties will bear their own costs and attorney's fees arising from this case.
